Termination of Agreement signed between Quick Advisory Services Pvt. Ltd. &

Sreemudranalaya Technology Pvt. Ltd.

Kindly refer to the agreement entered into by and between Quick Advisory Services Pvt. Ltd. duly signed by yourself as the Director and Sreemudranalaya Technology Pvt. Ltd. duly signed by the undersigned as the Director, which agreement was signed on 26th August, 2024.

As part of the agreement, it was decided that Quick Advisory Services Pvt. Ltd. (hereinafter referred to as QASPL) will acquire 75% of the shares of Sreemudranalaya Technology Pvt. Ltd. (hereinafter referred to as SMTPL) through a Rights Issue. The Agreement also referred to various action elements to be undertaken to ensure a positive growth of the Company.

It was also agreed that QASPL will arrange to pay a sum of INR 3.00 Crores to SMTPL upfront against 75% of the shares being divested which will permit SMTPL to clear its outstanding dues and other financial commitments. It is regretted that till date there has been no response from your end except some vague indications and assurances of some large investor willing to invest in the company, unfortunately none of which has materialised in the last nine months.

We also find that there is no effort made towards business development at all and the Company is missing out on various large GIS opportunities which is highly detrimental to the health of the Company. Further you have failed to remit the rents payable to the landlord which has been long outstanding and against which the landlord has issued an Eviction Notice which has also been shared with you but there has been no response from your end.

Under the circumstances, we are left with no option but to cancel the agreement signed between QASPL & SMTPL forthwith and request you to comply with the following immediately.

- Return all documents / assets pertaining to SMTPL and / or Dr. Earth Al Technologies Pvt. Ltd. immediately to the undersigned.

Return all keys of the Terminus Building office immediately.
